2012 Annual Meeting Proposal Review

Important Dates

April 15 th	Access granted to proposal review site
April 30 th	Proposal submission site closes at 11:59 PM EST
May 2 nd – 20 th	SOT review groups log into the site for final review
June 20 th	Proposal developer and proposal Sponsor notified via email of proposal decision.
July 1 st through August 12 th	Abstract submission site for invited speaker abstracts for tentatively accepted Symposia and Workshop sessions closes at 11:59 PM EST

Important Terms and Definitions:

Review Group(s) – SOT Committees, Special Interest Groups, Specialty Sections, or Task Forces.

Endorsement Decision – the formal decision by any Review Group to *endorse* or *do not endorse* a proposal identified by the submitter.

Sponsor – any group that the proposal submitter worked with for input on any proposal. Usually the proposal subject area closely matches that Review Groups' area of specialty. There can be only one Sponsor for any proposal.

Endorser – additional groups to which the proposal's discipline closely relates. There can be up to ***5 additional endorsers**. These groups can be identified by the submitter or self identified if there are no more than three endorsers listed.

Review Process

After 3 PM on Monday, May 2nd SOT HQ will forward to each review group the final list of proposals submitted, sorted first by the Sponsor then submission type, as an Excel spreadsheet. The sponsor names will be followed by all proposal endorsers in the order entered by the submitter.

Additionally, each endorsing group will be forwarded an at-a-glance list of proposals seeking an endorsement. Your group will be able to copy and paste individual control ID#'s into the site to search for those proposals that are seeking an endorsement from you (see page 5).

All scores/ranks/endorsement decisions/comments must be entered online by **May 20th at 11:59 PM EST**.

Sponsors

- Proposal Sponsors are expected to score, rank, provide a formal endorsement decision (*endorse* or *do not endorse*), and comments on each proposal listed in their Review Center.
- The review group designee will enter the final score, rank, comments and the formal endorsement decision online. The written comments/recommendations will receive particular weight during review the by Continuing Education and Scientific Program Committee.
- All scores and ranks should be assigned to like session types (symposium v. symposium, etc.). Please follow the rubric below to score ALL proposal submissions seeking sponsorship from your group.

SCORE: 1=Highest, 2=High, 3=Medium, 4=Low, or 5=Lowest

- All ranks will be assigned to like sessions based on the total number submitted for like session types. Should your group have proposals in like session types <20, please use the Max. Exceeded option from the drop down menu. Please follow the rubric provided below.

RANK: Assign a rank to each proposal beginning with 1 through greatest equivalent per session type. This ranking will allow the SPC to identify which program proposals are of the highest value to your Review Group.

- If you have five Symposium proposals, each would be assigned a rank of 1-5 with 1 being your group's top priority, 2 secondary, etc.
- If you were not provided with a copy of the proposal before it was entered online, it is acceptable to score and rank the proposal appropriately but you should not leave the proposal without the required information.

Endorsers

- Proposal endorsers do not need to score and rank proposals, but do need to provide an **endorsement decision** (*endorse* or *do not endorse*) and comments.
 - The review group designee will enter the formal endorsement decision and comments online.
 - The written comments/recommendations will receive particular weight during review the by Continuing Education and Scientific Program Committee.

ABSTRACT BODY: Most new compounds destined for commerce, and all compounds intended for human consumption, need to be assessed for their ability to disrupt reproduction and development. But the underlying biology can be confusing, the jargon employed by the cognoscenti can be impenetrable, and the implications of findings in these studies are often difficult to appreciate quickly. This basic course is designed to lift the veil of uncertainty around many of these issues. After a quick review of some of the key biology, we will touch on the characteristic study designs which generate the necessary data. The next two talks will focus on typical effects seen in adults and juveniles, and what impact these can have on the registration and use of the compound in Europe and the US, respectively.
