Dear Colleague:

As the Society of Toxicology Endowment Fund celebrates its 5th Anniversary, I am taking this opportunity to thank all of the SOT members who have so generously contributed and who have helped to grow the SOT Endowment Fund. I am happy to report that the Fund is doing extremely well. Net assets total \$1,599,639, which includes \$180,571 of additional contributions and matching funds; plus, realized investment gains of \$236,077 for the 2010-2011 SOT fiscal year.

The SOT Endowment Fund family also continues to grow. With the addition of the Neurotoxicology Fellowship Award Fund and Sheldon D. Murphy Memorial Fund, there are currently 32 Named Funds. The Fund also maintains four general Funds— Education, Global Activities, SOT Priorities, and Student Travel.

In other accomplishments, we underwrote 41 Endowment Fund awards during the Society's 50th Anniversary Annual Meeting last March. In addition, the Endowment Board presented an award, the Undergraduate Educator Award, to an SOT member who has made outstanding contributions to the teaching of undergraduate students in toxicology and toxicology-related areas, and whose efforts support SOT's strategic efforts to "Build for the Future of Toxicology." We also anticipate the Endowment Fund will underwrite an additional nine awards at the 51st Annual Meeting in San Francisco this coming March.

Finally, we are working on our strategy, which will set forth a number of long-range goals that I am confident will carry us forward in building for the future of toxicology. Given that "Global" activities are a major component of the Society's strategic plan, I am pleased to report that the International Activities Endowment Fund has been renamed to the Global Activities Endowment Fund. 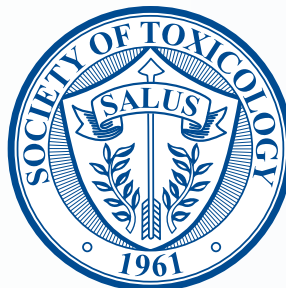
