As we look ahead to the SOT 2022 Annual Meeting in March, we hope you'll take the time to read our inaugural edition of the bi-annual newsletter. ## Traveling to SOT 2023

- This summer, California [restricted state-funded travel to 17 states](#) (except under limited circumstances), including: Alabama, Arkansas, Florida, Idaho, Iowa, Kansas, Kentucky, Mississippi, Montana, North Carolina, North Dakota, Oklahoma, South Carolina, South Dakota, Tennessee, Texas, and West Virginia over anti-LGBTQ legislation recently enacted in those states.
- SOT 2023 will be held at the Nashville Music City Center in Nashville, Tennessee, and OTA members who are employed by the State of California may need to plan accordingly when obtaining approval to attend the following year's annual meeting.
- OTA also raised concerns to the SOT Council about the recent anti-trans bills in Tennessee and the need to develop strategies to protect trans and nonbinary toxicologist who plan on attending SOT in 2023.
- OTA recommends that members contact their regional chapter officers as well as SOT Council directly to express their concerns about safety when traveling to SOT 2023 as well as future selection of National SOT meeting locations.

## Gender Identity and Expression at SOT

- SOT has updated the language in its [Commitment Statement to Diversity, Equity, and Inclusion](#), to include gender identity and expression, reflecting its dedication to improving representation in all forms within the Society: "...The Society asserts that to be a diverse, equitable, and inclusive organization, we must be considerate of many factors including, but not limited to, *gender identity*, race/ethnicity, employment sector, nationality and cultural background, geographic location, physical ability, and scientific expertise and perspective." The OTA was involved in this change by proposing guidelines for the Executive Council to follow.
  - All SOT bylaws were updated to be inclusive of all gender identities

## Call for Applicants: Postdoctoral Fellow Achievement Award (Deadline, November 1, 2021)

- This Award is given to a SOT postdoctoral fellow member (current or pending) who has demonstrated outstanding scientific achievement in the field of toxicology and who has also demonstrated leadership and service. Applicants for the Award are not precluded from applying for travel support or other SOT Awards outside of OTA. Applicants who are not OTA members are strongly encouraged to join.
