Day to Day: Integrating Clinical Toxicology

- Assist with toxicology situations and educate the Epidemiology Team
 - Mold, Methamphetamine labs, Industrial exposures, Risk assessment
- Assist with training and education with the Emergency Preparedness Team
 - Advanced Hazmat Life Support provider and instructor
 - Incident Command System trained
 - Outbreak planning
- Risk assessment and medical advice provided for overdoses or administration errors associated with vaccines

 - Teach approximately 10-15 hours of toxicology based curriculum each semester
