III. Key Outcomes in 2021-2022:

Activities:

A. 2022 SOT Annual Meeting Virtual Activities (e.g., courses, scientific sessions, or virtual receptions):

During the 2022 SOT Virtual Meeting, the Ethical, Legal, Forensics, and Societal Issues SS endorsed three scientific sessions.

- 1) Informational Session: *Honor Thy Stakeholders: How Toxicologist Can Better Incorporate Stakeholders into Research Communication, and Translation*
- 2) Symposium Session: *Disparities in Environmental Chemical Exposure and Health Risks*
- 3) Workshop Session: *Communicating Science in an Age of Misinformation and Mistrust*

Our SS Luncheon exceed our expectations of 25 participants, and we garnered a lot of interest for SS collaboration on webinars and SS development. We are following up on those connections in the next calendar year.

B. 2022 Awards Information:

The Ethical, Legal, Forensics, and Societal Issues SS Graduate Student Award was given to Shelby Zangari, who accepted her award in abstentia. Shelby is a graduate student at the State University of New York College of Environmental Science and Forestry. The award was given for Shelby's work titled, Daily Variation of Air Pollutants Near an Elevated Highway in Syracuse, NY.

Emma Karey accepted our postdoctoral Award for their work entitled Evaluating the relative inflammatory risk of passive tobacco product emissions in adults and children. Dr. Karey is a post doctorate at the New York University School of Medicine.

We also find the webinar process to be difficult when wanting to host a large series. Turning in paperwork for each webinar in the series has been a bit labor intensive. It may be better if we could turn in a package request.

We would like feedback from Council on what they believe we could do to bring more value to the Society. And we would like to have this as a continued conversation. Perhaps we could work collaboratively on reviewing and updating our Code of Ethics? It seems that would be an activity that ELFSI could co-lead with Council.

We are updating our roles and responsibilities. We are also updating our bylaws to reflect the current reality of how we are structured and to streamline operations. We may explore reframing our mission and vision statements.

The current officers are working hard to reinvigorate ELFSI and to raise ELFSI's profile. To that end, we are standing up a Program Committee as well as a Membership Engagement Committee.

We want ELFSI to be more visible to the Society, and we would like the entire Society to view ELFSI as the home for difficult conversations within the larger field of toxicology. To that end, we are interested in sponsoring more discussions on challenging ELFSI topics while providing a safe space for the exchange of ideas.
