C. Other Educational Activities Conducted (e.g., webinars, in-person meetings):

From September 2022 through November 2022, ELFSI co-hosted a joint webinar series with SOT's Sustainable Chemicals through Contemporary Toxicology SS on the ethics of conducting toxicological research and communicating novel findings.

The webinar series addressed issues and opportunities such as combating censorship and vilification, creating trust through integrity, transparency, how to communicate and share your science with the press and leveraging an ethics framework to be a steward of scientific integrity.
