- Webinar

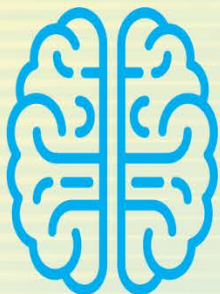
Financial considerations:

- After the initial seed funds (\$25,000) are repaid, PROFIT is split 50/50 with Component Groups (RC, SIG and SS)

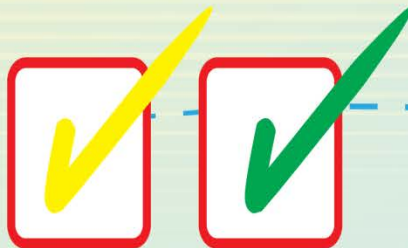
