PRESIDENT'S MESSAGE

Fellow Inhalation and Respiratory Specialty Section Members:

It is hard to believe it has been 8 months since our meeting in Baltimore, and the deadline for abstracts for the 2010 meeting of the SOT (the 49th!) has already passed. I hope everyone has had a successful year, and the IRSS will be well represented by abstracts at the upcoming meeting in Salt Lake City.

The IRSS was asked to sponsor one workshop, one continuing education course, and 8 symposia for the 2010 meeting, a very nice group of proposals. Of these, the CE course and 4 symposia were approved, for a 50% approval rating, far better than the results last year. In addition, we were asked to endorse a total of 2 additional workshops and one basic and one advanced CE course. It appears the IRSS will have a strong presence at this meeting: well done!

It is not too soon to be thinking about submissions for the 2011 meeting. The meeting in 2010 is an optimal time to get together with colleagues to define the subject, identify the speakers, and solicit feedback to strengthen the proposed sessions. The most significant reason for sessions we sponsored for 2010 not being approved was inadequate planning (too many speakers, too similar topics, or "insufficiently developed"). So please start planning now to help make the 50th anniversary meeting a milestone for IRSS as well as SOT.

The Mary Amdur Fund received a total of \$4000 in contributions between July 2008 and June 2009. These were matched by \$4000 from SOT. As we are all aware, the current economic climate has been hard on investments, but as of the last reported earnings statement, we have a net fund balance of \$30,169. This places it 6th highest of the 25 special purpose funds. We should be proud of the generosity of our membership in supporting this fund and its future awardees.

Nominations for the Mary Amdur Fund awardee (for an abstract submitted by a graduate student with a focus in environmental health) as well as the Graduate Student Award, the Postdoctoral Award, the Best Paper Award, the New Investigator Award, and the Career Achievement Award are all due December 18th. Nominations should be submitted to Vince Castranova (vic1@cdc.gov : Career Achievement) or Jim Wagner (wagnerja@msu.edu: all others). Please consider nominating a colleague or a student for these important forms of recognition.

One other note of interest: I know many of our members were excited by the establishment by NIH of a Special Emphasis Panel, Systemic Injury for Environmental Exposures, to provide a possibly more knowledgeable group for review of toxicological proposals. The plan was for a pilot series of three review sessions. That pilot period is over. My understanding from Sy Garte is that SIEE is not currently active, and that a final decision on the future status of SIEE is pending, and will be announced shortly.

I look forward to seeing you all in Salt Lake City in March.

18 March 2009

Meeting began at 6:45 pm with opening remarks from the President

Secretary/Treasurer Report

- Last year meeting minutes were approved
- Current Membership numbers were presented (250 active)
- IRSS budget balance was presented (\$9,607.00 as of 12/31/2008)

Technical Committee Report

- Harry Salem reported on behalf of the technical committee
- 2 newsletter were sent out over the past year
- Technical Committee Meeting was held 17 March 2009
- 21 people attended the meeting, and three speakers made presentations

Program Committee Report

- For 2009 meeting
 - IRSS submitted 3 symposia topics, but only 1 was approved
 - IRSS co-sponsored 7 symposia, 5 of which were accepted
- Membership discussed ways to increase symposia success
 - Must have complete proposal with speakers and their abstracts
 - Increase number of symposia submitted

Meeting was closed at 7:30 pm

The Technical Committee met on Tuesday March 17, 2009 at 7:00 AM with 21 members in attendance.

Three speakers included John Whalan who discussed the status of the OECD guidelines and guidance development; Juergen Pauluhn who made a presentation provided evidence that the MMAD range in repeated exposure studies should be lowered, and George Woodall made a presentation on the development of his toxicology data base.

There was a lively discussion following Juergen's presentation, although there were no dissenting opinion. The discussion touched on whether changes were necessary for TG412, and TG413 as well as GD39. It was agreed these documents were fine the way they are, and GD39 includes the MMAD issue. There was also an agreement that there should be a TG for inhaled nanoparticles.

STATUS OF OECD INHALATION PROJECTS

September 11, 2009

On April 1, 2009, the following draft OECD inhalation documents were approved by the 21st OECD Working Group of National Coordinators of the Test Guidelines Programme (WNT):

TG 403 (updated) – Traditional acute LC₅₀ protocol and Cxt protocol guideline

Performance Assessment Report (PAR) for the updated TG 403

TG 436 – Acute toxic class method guideline

Performance Assessment Report (PAR) for TG 436

TG 412 (updated) – Subacute (28 day) inhalation toxicity guideline

TG 413 (updated) – Subchronic (90-day) inhalation toxicity guideline

GD 39 – Guidance document on acute inhalation toxicity testing

The WNT also approved a new project—the development of a Guidance Document on the derivation of an Acute Reference Concentration (RfC). The USA has the lead on this project.

On September 7, 2009, GD 39, TG 403, TG 436, TG 412, and TG 413 were adopted by the OECD Council. English and French versions of these documents can be found on the OECD website (www.oecd.org/ehs/).

An OECD Guidance Document on histopathology for inhalation toxicity studies is currently under development. This GD will supplement the pathology guidance found in TG 412, TG 413, and the chronic guidelines (TG 451, TG 452, and TG 453). The pathologists drafting the histopathology GD are Drs. Roger Renne (lead), Jeff Everett, Jack Harkema, and Charles Plopper of the USA, and Martin Rosenbruch of Germany. The first draft was recently circulated by the OECD Secretariat for comment.

TG 433, an acute fixed concentration procedure, was withdrawn by the UK in 2007 in response to concerns by inhalation experts over the validity and practicality of using “evident toxicity” as an endpoint in inhalation testing instead of death. The UK is drafting a revised TG 433 for adoption into the EU Test Methods Regulation and for resubmission to the OECD TG Programme.
